The electricity and gas you purchase from DC Power Co is 100% carbon neutral, at no extra cost to you.

HOW WILL I RECEIVE MY BILL?

We'll send all communications to the email address you used to sign up. Your gas bill will be delivered separately to your electricity bill.

WHAT IS AN ACCOUNT REVIEW?

Your account review is your bill, it outlines what you used during the billing period and what you purchased, as well as any amount owing at the end of the billing period. This is sent bi-monthly and comes with an attached PDF outlining everything that makes up your bill, including usage charges, daily supply charges and other things like concessions (if applicable).

VARIATION OF TARIFFS

If we vary our tariffs and charges for the sale of gas to you under this contract, we'll give you notice as soon as reasonably practicable, but no less than five business days in advance. This will usually be by email, or your preferred method of communication.

OTHER FEES

In addition to the applicable prices, you may incur other fees. Information is available at dcpowerco.com.au/fees. Where a fee is to be applied, we will endeavour to inform you of the fee(s) and gain your consent before the service is provided.

NO LOCK-IN CONTRACTS

At DC Power Co we believe our customers should always have a choice. You have the right to join DC Power Co and the right to move away if you wish. We have no exit fees or lock-in contracts so if you decide that we're not right for you, you're free to leave whenever you wish (although we hope you won't).
