WHAT IS THE DC FEE?

We have no vested interest in getting you to use more electricity from the grid and no financial interest in selling you more. Unlike other power companies, our fee is not added to your usage rate, it's called out on your bill. This means for a flat \$11 (GST inc) per month you will receive:

- cost price electricity and the ability to sell your excess solar back to the grid
- our Solar Alert service, so you know when your solar isn't working
- advice on optimising your solar system to help reduce your bills
- advice on when solar, or a battery or upgrade, might be right for you.

CARBON OFFSET

The electricity you purchase from DC Power Co is 100% carbon neutral, at no extra cost to you.

VARIATION OF TARIFFS

If we vary our tariffs and charges for the sale of electricity to you under this contract, we'll give you notice as soon as reasonably practicable. This will usually be by email and no less than five business days in advance, or 10 business days in advance in Queensland if this variation is an increase.

OTHER FEES

Time of use and flexible tariffs:

These tariffs consist of a daily supply charge, and different per kWh energy rate for peak times, off peak times and for flexible tariffs, "shoulder" times.
